Sir/Madam,

I am directed to refer to this office letter No.A-34012/09/2016-DE dated 05.09.2016 wherein, notification for conduct of Limited Departmental Competitive Examination for promotion to the cadre of Inspector Posts for the year 2015-16 was issued.

2. With regard to the above notification, Additional D.G. APS had requested for providing an additional time of 10 days for submitting applications by the APS candidates. It had also been pointed out that age relaxation of 5 years has been granted to the officials serving in APS for appearing in the Inspector Posts LDC examination vide letter No. 7-14/2009-SPB-II dated 09.09.2015, whereas in Para 6 of the notification, it has been stated that candidates on deputation to APS are not eligible for any age relaxation.

3. The issues raised by the Additional D.G. APS have been examined. The competent authority, after consideration of the issues, is pleased to order the issue the following amendments with regard to the conduct of the examination cited above.

(A) Officials serving in APS may be granted age relaxation of 5 years for appearing in the Inspector Posts LDC examination as already instructed vide letter No. 7-14/2009-SPB-II dated 09.09.2015.

(B) The dates of examination have been revised from 15th & 16th October, 2016 to 22nd & 23rd October, 2016 and the timings of examination will remain same. The revised Annexure-II is enclosed for guidance.
