The service rendered will not count for the purpose of fixation of seniority or continuance in the grade. This temporary & officiating arrangement will automatically cease after 11 months from the date of joining of the officer or till regular incumbent joins or any other administrative exigency whichever is earlier. The officers of Part-B should positively relieve themselves from the promotional post on the date of completion of 11 months from the date of assumption of charge of the promotional post if not reverted earlier and send a copy of relinquishing charge report to this office.
