

Regarding clarification on premature exit of GDS under SDB TPS-Lite).

Sir,

This Directorate has been receiving a number of references from Subscribers of SDBS, Circles and concerned Staff Unions underscoring the issues blocking payment of dues to GDS employees. The clarification, contained herein is regarding the pre-mature exit from the Scheme and the corresponding amount that can be withdrawn duly obtained after consulting PFRDA.

In this regard, it may be appreciated that the Subscribers who want to initiate pre-mature withdrawal from SDBS under NPS-Lite and have never received Swavalamban co-contribution from Government and corpus of such GDS officials doesnot exceed rupees one lakh, are eligible to withdraw entire corpus in lumpsum without any requirement for purchasing annuity. In other words, all subscribers of SDBS who wants to initiate pre-mature exit (i.e. before 25 years in general) viz resignation, discharge, promotion etc can withdraw the entire corpus in lumpsum if their accumulated wealth is less than rupees one lakh, without investing in Annuties.

Further, it is informed that all GDS under NPS-Lite are already permitted to exit/ superannuate from the system at 65 years of age and the same is fully facilitated by the CRA.
