
Posting orders of the officials allotted to regions will be issued by the concerned regions immediately against vacant posts in HSG-I cadre.

In case an official is not willing to accept promotion his/her declination letter in writing should be obtained and forwarded to this office within 30 days from the date of issue of this order. Those officials who declined promotion will be debarred for promotion for one year from the date of their declining promotion.

The above official who is drawing pay matrix level 7 will continue to draw the existing level and no benefit of Pay fixation shall accrue for such regular promotion.


In case of any vigilance/ disciplinary case is pending against the official or punishment is current, he/she should not be promoted and a detailed report should be submitted to C.O.
