Sir,

This is in continuation of this office letter of even no. dated 25.02.2019 on the subject cited above, vide which, the approval of the Competent Authority was conveyed to your office for creation of a new Postal Division at Mandla by bifurcation of the existing Balaghat Postal Division.

2. In this regard, this is to further inform that the above approval of the Competent Authority was given with the following conditions:

- (i) A target of increase in revenue by at least 50% in one year may be assigned to both the HOs i.e. Balaghat HO and Mandla HO (This includes their SOs and BOs).
- (ii) Once target is achieved or after the lapse of one year (whichever is earlier) concurrence of JS&FA and approval of Secretary (P) would again be sought for creation of Mandla Division by bifurcating Balaghat Division.
- (iii) In case there is failure to achieve the above target then after one year both the Division would automatically be combined and the new created Mandla Division would cease to exist.
- (iv) In case of failure to achieve the target, all diverted posts would automatically be reverted to their original Divisions.

3. The Circle is, therefore, requested to comply with the above conditions and take further necessary action accordingly.


