\*Exam will commence at 10:00 AM sharp in all the Circles and both the Paper-I & II will be conducted in continuity in one sitting from 10:00 hrs to 12:10 hrs. There will be 10 minute's break in between Paper-I and Paper-II, but, candidates cannot be allowed to leave his/her desk.

2. **Vacancies:** Number of vacancies in MTS cadre (category wise) available under Recruiting Division / Unit – wise for the year 2019 & 2020 will be published shortly.

3. **Eligibility Criteria:** - As per the Department of Posts' MTS (Group 'C' post) Recruitment Rules, 2018 notified in GSR 781 (E) dated 16.08.2018 (**Annexure-II**), the following category of GDSs are eligible to appear in the examination:

i. Gramin Dak Sevaks (GDSs) who have worked regularly for three years in that capacity as on the **01.01.2019** for the vacancy year **2019**.

ii. Gramin Dak Sevaks (GDSs) who have worked regularly for three years in that capacity as on the **01.01.2020** for the vacancy year **2020**.

4. **Educational Qualification:** Not applicable.

5. **Age limit:** There shall be no upper age limit for Gramin Dak Sevaks.

6. **Pattern & Syllabus of Examination:** The examination will be conducted as per the revised pattern and syllabus circulated by Directorate vide letter No. 17-08/2018-SPB-I dated 10.05.2019 under Annexure –‘A’ read with letter No. 17-08/2018-SPB-I dated 26.06.2019, 28.06.2019, 11.07.2019 & 23.07.2019. Details of Pattern and Syllabus are furnished in **Annexure-III**.

7. **Centres of Examination:** The examination will be conducted at the following centres:

- Kolkata Centre – I ( for the candidates of Kolkata Region, M&BD Region, HQ Jurisdiction except A&N Islands)

- Siliguri Centre (For Candidates of North Bengal Region)
- Port Blair Centre (For candidates of A&N Islands)
- Gangtok Centre (For candidates of Sikkim State).
