3. BCR officials / officials awarded MACP-II & MACP-III promoted under this memo will continue to draw the existing Grade Pay. No benefit of pay fixation shall accrue for such promotion against the functional post in HSG-II cadre.
4. The promotion is subject to the official's joining in the promoted post.
5. If an official declines promotion he may be permitted to do so within Seven (7) days from the date of issue of this order and the prayer for declination in original should be sent to Circle Office.
6. In case, any Vigilance /disciplinary case is pending or punishment is current against any of the above mentioned official, he should not be promoted without obtaining specific orders from the Circle Office. The official against whom any punishment is current should not be promoted before expiry of currency of punishment. A report in this regard may be submitted immediately to Circle Office.
