The service rendered will not count for the purpose of fixation of seniority or continuance in the grade. This temporary & officiating arrangement will automatically cease after 11 months from the date of joining of the officer or till regular incumbent joins whichever is earlier.

The officers of Part-B should positively relieve themselves from the promotional post on the date of completion of 11 months from the date of assumption of charge of the promotional post and send a copy of relinquishing charge report to this office.
