Subject Notification in connection with holding of Competitive Examination for filling up the vacancies of Multi-Tasking staff cadre for the vacancies of the year 2018 as per MTS Recruitment Rules 2018 -Reg

In partial modification of this office letters of even no dated 21-08-2018 & 04-09-2018, eligibility criteria as per Department of Posts (Multi Tasking Staff) Recruitment Rule 2018 is stated as under :-

- 1) There shall be no upper age limit for Gramin Dak Sevak.
- 2) (a) 25 % by direct recruitment on the basis of Competitive Examination restricted to Gramin Dak Sevaks of the recruiting division, who have worked regularly for three years in that capacity, as on 1st day of January of the year to which the vacancy(ies) belong to or as per the guidelines issued by the Govt. of India from time to time, failing which,
(b) By direct recruitment on the basis of Competitive Examination restricted to Gramin Dak Sevaks of all other divisions of the Circle, who have worked regularly for three years in that capacity, as on 1st day of January of the year to which the vacancy(ies) belong to or as per the guidelines issued by the Govt. of India from time to time, failing which,
(c) By direct recruitment from open market as per scheme circulated by the Department of Posts from time to time ;
- 3) Educational qualification for Direct Recruitment :-
 - (i) 10th Standard pass from a recognized Board
 - (ii) Knowledge of local language of the concerned State or UT. The candidate should have studied local language at least upto 10th Standard.
 - (iii) No educational qualification is prescribed for Direct Recruitment of casual Laboueres.

The vacancies in MTS Cadre for the year 2018 circulated under this office letter of even no dated 14-08-2018 may be treated as cancelled consequent on issuance of revised vacancy statement for the year 2018 communicated under this office letter dated 04/09/2018.
