Sub: Relieving of GDSs selected for the post of Territory Officer in India Post Payment Bank on temporary engagement basis.

This has a reference to PBI Division letter no. 1-2/2017-PBI dated 24.04.2018 wherein instructions have been issued to all HoCs for relieving of GDS selected for the post of Territory Officer in India Post Payment Bank on Temporary engagement basis for a period of 2 years extendable by one year.

2. In this context, the following instructions are issued in connection with immediate relief of selected GDS as Territory Officer in IPPB :-

I. The selected candidate will be treated as on leave without allowance in Department of Post. Before proceeding to IPPB, the selected candidate will apply for leave without allowance to the Divisional Head for the period of their deputation to IPPB.

II. The Divisional Head will sanction leave without allowance in relaxation of existing rules on sanction of leave for the period of deputation before they are relieved

III. Substitute arrangement may be made by combination of duties of GDS failing which redeployment of GDS from adjoining/nearby Post Office. Combined Duty Allowance admissible as per rules may be paid.

IV. In case the selected candidate is GDSBPM, he/she will hand over existing BO accommodation to the substitute for functioning of BO.

3. Further, for these GDS posts, provisional engagement should be completed within a period of six months.

4. The same may be brought to the notice of all concerned.

5. This issues with the approval of competent authority.
