**NOTIFICATION FOR ENGAGEMENT OF DOCTORS ON CONTRACT BASIS IN POSTAL DISPENSARIES OF JALPAIGURI AND SILIGURI**

Applications are invited in the enclosed format from willing and eligible candidates of Indian citizen for engagement of doctors on contract basis in Postal Dispensaries of Jalpaiguri and Siliguri. The application must reach the office of the undersigned on or before **15.02.2017** by Regd. Post or Speed post only. Application received from other than the Regd. Post/Speed Post will be rejected straight way. No application will be entertained after the stipulated date under any circumstances and will be rejected. The application should be super scribed as "**Application for engagement of Doctors on contract basis**"

**The following terms and conditions would govern all engagements of contractual doctors in the P&T Dispensaries of Jalpaiguri and Siliguri.**

1. The minimum qualification required is of an MBBS Degree.
2. The age of applicant should not exceed 62 years as on the date of submission of application
3. The selected applicant will be entitled to a lump sum payment Rs.60,000/- per month.
4. The appointee will be initially engaged for a period of six months, extendable periodically on a six monthly basis for a period not exceeding a maximum of two years or till the age of 65 years or till the regular incumbent joins, whichever is the earlier.
5. The selected candidate will be posted in any Postal Dispensary and will be functioning under the control of the Chief Postmaster General of the Circle in which the Dispensary is located.
6. The Department can terminate the contract even before the expiry of the fixed term if the services of the medical officer are not found to be satisfactory.
7. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowance will be admissible in cases of such assignment.
8. The appointee shall not be entitled to any benefits, like Provident fund, Pension, Gratuity, Medical Attendant Treatment, Seniority, Promotion, Housing, etc. or any other benefit available to the Government servants, appointed on regular basis.
9. Non-practicing allowance will not be admissible.
10. The appointee will not have any claim or right for regular appointment to any post under Central Govt. Health Scheme.





11. Only consolidated salary will be admissible. No dearness allowance or any other allowance is admissible to the appointee.
12. The appointee shall be on the whole time appointment of the appointing Circle office and shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
13. The appointee is not entitled to any TA for joining at the place of posting on accepting appointment.
14. The applicant shall be allowed one day's Casual leave for every 30 days period of service and no encashment will be allowed. The leave due shall be calculated for each short term contract and no carry forward of leave will be allowed. In case of absence from duty, proportionate deductions will be made from the appointee's remuneration.
15. Other conditions of service will be governed by relevant rules and orders issued from time to time.
16. The Doctor would be recruited through an interview by a Selection committee after formation of a panel of applicants by advertisement in local newspapers.



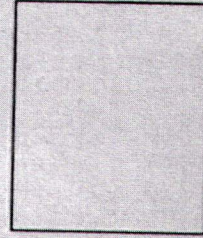
