The Chief Postmaster General, West Bengal Circle is pleased to declare the supplementary result of Competitive Examination for recruitment to the cadre of Postman/Mail Guard amongst GDSs arising out of the unfilled vacancies of GDS quota for the vacancy year 2019 consequent to declination of the successful candidates which is furnished in Annexure-I as per instructions contained in Directorate's letter No. 17-08/2018-SPB-I dated 20.06.2019.

The final re-casted merit list of the candidates in some Division whose results were declared in the Memo No. Rectt/X-16/PM-MG/2019/AD(R) dated 11.03.2020 read with the results in Annexure-I. In respect of candidates of a particular Division who scored equal marks, their inter-se seniority is fixed as per the Rules on the subject. The result published on 11.03.2020 is also available in the Departmental website.

The candidates who have already been declared successful in the GDS to PA/SA Exam. held on 15.09.2019 & who have joined/reported as PA/SA have also come under merit in the selection zone. Their names have been excluded while drawing the supplementary merit list of the successful candidates in Annexure-I. 


