Subject:- Allotment of surplus qualified candidates in c/w Limited Departmental Competitive Examination (LDCE) for promotion of Postman/Mail Guard/MTS to Postal Assistants/Sorting Assistants for the vacancy year 2021 (01.01.2021 to 31.12.2021), held on 24.10.2021.

The Competent Authority is pleased to declare the allocation of Division/Unit in respect of the surplus qualified Postman/Mail Guard & MTS of LDCE for promotion to the cadre of Postal Assistants/Sorting Assistants for the vacancy year 2021 (01.01.2021 to 31.12.2021). The allotment has been done on the basis of merit, order of preference submitted by the candidates & availability of vacancies in the respective category by following the relevant Recruitment Rules of PA/SA, 2015 & Dte's letter No. 04-08/2019-SPN-I dated 26.07.2019 & 04-08/2019-SPN-I dated 11.12.2020.

The list of surplus qualified candidates with the allocation of Division/Unit who could not be allocated to the respective parent Division/Unit in PA/SA due to non-availability of vacancies in the respective category is annexed as **Annexure-I**.

12 number of ST vacancies are remained unfilled due to non-availability of qualified candidates in the said category. (**Annexure-II**)

Regions/Divisions are requested to verify the relevant particulars of the selected candidates at their own level. In case, it is subsequently found that any of the qualified candidates was not eligible to appear in the examination under the extant rules or instructions on the subject for any other reasons or in case any mistake is found with regard to list of qualified candidates for any reason whatsoever, the action taken may be brought to the notice of Circle Office.

The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Regions/Divisions/Units. In case there are any mistakes in the details of candidates, the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the promoted/selected candidates was not eligible to take the examination under the existing rules/instructions on the subject or for any other reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject or orders of Hon'ble CAT/High Court, if any.

Results of candidates claiming SC/ST status may be thoroughly verified and any discrepancy noticed may be intimated to Circle Office.

The selection & appointment of the candidate belonging to SC/ST is subject to verification of their caste status by the Divisions concerned as per extant instructions on the subject.

It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Regions/Divisions are requested to verify the current status of the candidature of the qualified candidates before appointing the candidate. The candidate against whom vigilance or disciplinary case is pending/ those undergoing punishment should not be appointed and such cases should be referred back to Circle Office.

The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules & verification of genuineness of various mandatory certificates of the candidates by the concerned Head of the Divisions/Units.

The appointing authorities are requested to carry out all the required pre-appointment formalities as per relevant rules & instructions issued time to time.

The result is prepared as per the guidelines received from Directorate and in accordance with the merit and preference exercised by the candidates. Therefore, no representation for re-allotment will be considered.


The Divisional Heads may ensure that provisional *appointment orders are issued to the candidates within 15 days positively.*

If any candidate is unwilling to accept promotion, he/she should submit application for unwillingness to the Divisional Head on or before **20.06.2022**. Divisional Head will send the original application for unwillingness of candidates duly attested by them to concerned Regional office on or before **23.06.2022**. Regional office will send all the unwillingness applications received from Divisions in one lot to this office on or before **27.06.2022**.

The contents of this memo may be brought to the notice of all concerned.


