**Minutes of the 'Committee on Compassionate Engagement (CCE) Meeting'  
held on 28-09-2022 to consider the cases of engagement in GDS cadre on  
compassionate ground**

The 'Committee on Compassionate Engagement (CCE)' met on 28-09-2022 to consider the cases of engagement to GDS posts to the family member of the deceased GDSs on compassionate ground. Following officers were present in the CCE as constituted vide CO Memo No. Rectt/CCE/RLX/MAR'2022 dated 19.04.2022

2. Total 29 cases were placed before the CCE for consideration out of which 15 cases have been recommended and the list is placed at **Annexure-A**.

3. Total 04 cases have been considered but not recommended due to having found over-aged i.e. above 40 years (or above permissible age limit w.r.to respective categories of the applicants) and the list is placed at **Annexure B. The power of relaxation of upper age limit is vested on the HOC.**

4. Total 09 cases have been found belated but recommended considering several aspects and the list is placed at **Annexure C** out of which 06 cases are subject to approval of the HOC.

5. Total 01 case has been found not having required educational qualification hence the applicant has been recommended to be engaged as GDS Dak Sevak as per Directorate Memo No. 17-01/2017-GDS(Vol – I) dated 09.02.2022 and the list is placed at **Annexure D**. He may be given considerable time up to maximum 3 years for acquiring of minimum required educational qualification as prescribed with the following terms and conditions –

- i) He will be at the minimum of TRCA. Annual increment shall not be allowed until acquiring the minimum required educational qualifications and until regularisation of engagement.
- ii) Engagement shall be provisional subject to provisions under Rule 8 of GDS (Conduct & Engagement) Rules 2020 in the case of not acquiring minimum required educational qualifications.
- iii) Transfer shall not be considered before regularisation of engagement.
