The Competent Authority is pleased to appoint provisionally the following outsider candidates in the cadre of PA(SBCO) in West Bengal Circle in the Pay Band of Rs. Rs. 5200- 20,200/-+pay matrix level 4 plus other allowances as due and admissible with effect from the date of joining in the Department and they are allotted to Regions as particularized below subject to the following terms and conditions.

- 2 The candidates are given to clearly understand that their appointment as such is purely temporary subject to the provisions of CCS (Temporary Services) Rules, 1965 as amended from time to time and will not confer upon them any right for continuance in the grade of service and their appointment is liable to be terminated any time by giving one month's notice without assigning any reason. The appointing authority also reserves the right of termination of service of the temporary official forthwith before expiry of notice period by making payment of a sum equivalent to pay and allowances for the unexpired portion of the notice period.
- 3. This provisional appointment of the candidates is subject to satisfactory verification of their Educational Certificate/Cast Certificate/Ex-Servicemen Certificate/Disability Certificate/Date of Birth Certificate/Character and Antecedents and other documents by the competent authority.
- 4. The candidates are given to clearly understand that in case character and antecedents of the candidate is found not verified or any false information is given by the candidate in his/her self declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken, as a consequence.
- 5. In case a candidate belonging to reserved communities is unable to produce a certificate from any of the prescribed authorities, he/she is given to understand that the provisional appointment is subject to his/her furnishing the prescribed Cast certificate within two months.
- 6. If any information or document submitted by the candidate is found incorrect at a later stage, he/she shall be terminated from the service.
- 7 The candidates will have to undergo in House training for 12(twelve days) to be imparted by the Divisional Heads/Head of Units.
- 8 The candidates are liable to serve in any post of PA(SBCO) cadra in West Bengal Circle including Sikkim State and A & N Islands. They are also liable to serve in any part of India under special circumstances and to work in Field Service at the time of war or frational emergency.

- 9. The candidates are directed to understand that the In-House training imparted to them will not be treated a substitute for Induction training. On allotment of seats by the PTC they will be sent to PTC for Induction training.
- 10. The candidate will be under probation for a period of two years or till successful completion of Induction training whichever is later. The clearance of probation period will be reviewed by Departmental Confirmation Committee after two years.
- 11 The candidates will be entitled to get regular pay and allowances in the pay band of Rs. 5200/- 20200/- from the date of joining i.e from the date of commencement of in-House training.
- 12. The appointment is not covered by the existing system of "defined benefit pension" and he/she will be governed by the New Pension Scheme introduced as per notification of the Ministry of Finance, Department of Economic Affairs (ECB & PR Dn) resolution No 5/7/2003-EDC & PR dated 10.10.2003 communicated vide No.4-28/03-Pen dated 17.12.2003 of Ministry of Communications & IT, Department of Posts, India effective from 01.01.2004. In short, he/she is not governed by the existing CCS (Pension) Rules. 10% pay plus DA paid to him/her or the amount prescribed by the Govt. of India from time to time will be recovered by the drawing officer as monthly contribution for pensionary benefits which will commence from the salary for the month following the month of appointment.
- 13. The Seniority in the cadre will be governed as per rule.
- 14. Other conditions of service will be governed by the relevant rules and orders in force as amended from time to time.
- 15 The candidates who are already in service should obtain "No Objection Certificate" from his/her present employer and submit the same at the time of joining after acceptance of the resignation by the present employer.
- 16 if the appointment is under Ex-servicemen quota, fixation of pay may be regulated in accordance with the order contained in MOF O.M No 8(34)-Estt-/57dated 25.11.58 and FG (8) E-III/03 dated 11.4.1963 as amended from time to time. The option is to be exercised within three months from the date of appointment/joining.
- 17. The posting order of the candidates allotted to the Region will be issued by the concerned Region.

The candidates should join within 15(fifteen) days from the date of receipt of their posting order
