With reference to A&N Islands Division letter mentioned above, I am directed by the competent authority to intimate that, the rate chart of daily wages issued by the Labour Commissioner, Andaman & Nicobar Administration vide no. 16/1/MW/2019-20/LC&DET/709 dated 29.07.2022 has been examined with following observations:

- The present rate in West Bengal Circle for Daily Rated Mazdoor(DRMs) @ Rs. 421/(Rupees four Hundred twenty one) only for 8 (eight) hours circulated vide this office
 memo of even number dated 20.10.2023 according to the Joint Labour Commissioner,
 Govt. of West Bengal vide memo no. 09/Stat/12 RW/03/2023/LCS/JLC dated 20.03.2023
 is applied for entire Circle.
- 2. Despite of a 'Division' (A&N Islands) in this Postal Circle, on the basis of rates of Unskilled and Skilled/Clerical fixed by the Labour Commissioner, Andaman & Nicobar Islands Administration as a separate Union Territory of India may be adopted in Andaman & Nicobar Division as follows:

Category of worker	Minimum wages per day
Unskilled	Rs. 517/-
Skilled/Clerical	Rs. 659/-

The above rates of wages is applicable for such Daily Rates of Daily rated Ticca Workers/Daily Rated Worker/Piece Rated Worker as the case may be, who are not being paid as per Minimum Wages act and also engaged for seasonal/occasional work in Post Offices/R.M.S Offices/Business Offices/Administrative Offices etc. for the 8 (eight) hours duty or part thereof. However, for performing duty below 8 (eight) hours, wages should be paid on pro-rata basis i.e. wages @ Rs. 64.62 (sixty four rupees and sixty two Paise) only for Unskilled and @ Rs. 82.37 (eighty two rupees and thirty seven Paise) only for Skilled/Clerical per hour should be paid.
