3. The Promotion will be effective from the date of assumption of charge of the post of Inspector Posts.

4. Officials shall be on probation for a period of two years.

5. Request for re-allotment to any other Circle/Unit shall not be entertained under any circumstances. Therefore, Regions should refrain themselves from making such recommendations.

6. It is the official's responsibility to send a copy of charge report on assumption of charge of the post of Inspector Posts directly to Directorate through email at <u>adspn.dte@indiapost.gov.in</u> as well as to C.O. for information & record.

7. Officials will be relieved within 10 days from the date of issue of this order subject to the condition mentioned in Para-10 below.

8. In case of official(s), who is not willing to accept his/her promotion, his/her declination letter in writing shall be forwarded by the Regional Office to C.O. for onward submission to Dte. latest by 25.10.2023.

9. Region shall send a consolidated report on date of reliving and date of joining in respect of all the officials latest by **01.11.2023**.
