The Competent Authority is pleased to promote the PA cadre officials mentioned in **Annexure-I** in the pay band Rs. 5200/- to 20,200/- (PB-1) with Pay Matrix Level 4 to LSG cadre (Postal Line) in the pay band of Rs. 5200/- to 20,200/- (PB-1) with Pay Matrix Level 5 on regular basis against the vacancy year 2022 as per recommendation of DPC held on 26-02-2024 with effect from the date(s) they actually assume the charges of the promotional post.

2. The orders of the Competent Authority regarding allotment of the PA cadre officials on their promotion to LSG cadre in Postal line on regular basis to the Divisions mentioned against each in the **Annexure-I** are issued to have immediate effect.
3. The orders of the Competent Authority regarding re-allotment of one approved LSG official who was earlier promoted to LSG Cadre vide CO of even no. dated 18-08-2023 is issued to have immediate effect as mentioned in **Annexure-III**.
4. The Divisions will issue posting order of the officials allotted to their divisions within **10 days from the date of issue of this order positively without any deviation**.
5. The officials who are already in receipt of Pay Matrix Level 5 or above will continue to draw the existing Pay Matrix Level in the respective pay band. If any official is yet to draw the Pay Matrix Level 5, he/she may give option for choosing date of fixation of pay under FR-22(I)(a)(1) within one month after joining in promotional post.
6. If any disciplinary/ vigilance case is pending or punishment is current against any official he/she should not be promoted and a report to that effect should be submitted to this office immediately.
7. As per norms stipulated in OM No. 4-7/MACPS/2019-PCC dated 30-10-2019 circulated vide CO memo no. Est/B/Z-7th CPC (MACPS)/2016 dated 30-10-2019, if any official declined the regular promotion before becoming entitled to an upgradation under MACPS, no financial upgradation under MACPS shall be allowed as such the employee has not stagnated due to lack of opportunities. If, however, financial upgradation under MACPS has been allowed due to stagnation and the employees subsequently refuse the promotion, it shall not be a ground to withdraw the financial upgradation. The official, however, will not be eligible to be considered for further financial upgradation till he agrees to be considered for promotion again and in such case the second or next financial upgradation shall also be deferred to the extent period of debarment due the refusal of promotion.
8. If any official declines promotion, a written declination in original should be submitted within **07 days** after posting order issued by the Divisions/Units and the same should be sent to this office through Division within **7 (seven) days** without fail. The officials decline promotion will be debarred for further promotion for one year from the date of their declination.
9. The orders of the Competent Authority regarding inter-Division transfer in the cadre of LSG (Postal General Line) as mentioned in **Annexure-II** are issued to have immediate effect without any TA/TP. If any disciplinary/ vigilance case is pending or punishment is current against any official he/she should not be relieved to join in his/her new place of posting and a report to that effect should be submitted to this office immediately.


