Sir/Madam.

I am directed to refer to this office letter No.A-34012/3/2012-DE dated 10th April 2012 wherein, notification for the year 2011-12 was issued. The last Limited Departmental Competitive Examination for promotion to P.S. Group 'B' cadre for the year 2011-12 was conducted on 3.6.2012

- 2. It has now been decided by the Competent Authority to conduct the Limited Departmental Competitive Examination for promotion to P.S. Group 'B' cadre for the year 2012-13 onwards in-house on the old pattern using OMR method for evaluation at the 23 Circle Head Quarters. The eligible Applicants will be permitted to appear in the examination from their respective Circle Headquarters only and not from any other Circle in any circumstances. For newly created Telangana Circle, the Centre will be 'Hyderabad' and for Andhra Pradesh Circle, it will be Vijayawada.
- 3. Applicants serving in APS on deputation will also appear from the examination centres of their parent Civil Circles. The APS authorities will send the Applications of the Applicants working in APS to the concerned Nodal Officer of the Circle by furnishing the eligibility details and their recommendations.

4. Applications are invited from the willing Applicants in the format enclosed. The schedule of the examination is given below.

5. The Examination will be conducted on pattern and syllabus issued by SPG Section vide Letter No.9-59/2010-SPG dated 08.03.2011 and 21.04.2011. Syllabus prescribed for this Examination is given in **Annexure I**.

6. As per the Recruitment Rules of the Postal Service Group 'B' cadre, the seligibility criteria for appearing in this Examination is as under:-



- (a) For I.P. line Quota, Inspectors Posts and Assistant Superintendents having put in five years regular service from joining in I.P. cadre on the crucial date of eligibility for the examination of a particular year;
- (b) For General line Quota, officials belonging to Higher Selection Grade-I, Higher Selection Grade-II and Lower Selection Grade having put in five years regular service in either or all the three cadres together on the crucial date of eligibility for the examination of a particular year;

Note: Postal/Sorting Assistants placed in TBOP/BCR scales/levels under Financial upgradation/Assured Career Progression Schemes are not eligible to appear in the examination. The officials of Postmaster Grade-I, Grade-II and Grade-III are also not eligible.

UR Applicants	50% marks in each paper i.e. 150/300 marks and 50% in aggregate i.e. 300/600 marks (2 Papers of 300 marks each)
SC/ST Applicants	40% marks in each paper i.e. 120/300 marks and 40% in
	aggregate i.e. 240/600 marks (2 Papers of 300 marks each)

- 11. The eligibility of the applicants having any of the following infirmities should be decided by the Circles in the light of letter No.9-59/2010-SPG dated 08.03.2011 issued by SPG Section.
 - If, any disciplinary action is pending or contemplated;
 - (ii) If, any punishment is current;
- (iii) If, there is any adverse entry in the APAR/ACR in the last 5 years;
- 12. The Nodal Officer for the conduct of exam will be the DPS (HQ) of the Circle, who will have to verify the details of the candidates with reference to columns of the Application form and details filled therein by the candidates. Each case filled in the enclosed Annexure III should be individually recommended by the Nodal Officer and the Applications of the eligible Applicants, duly recommended by the Nodal officer alongwith duly filled in Annexure-III should be sent to Directorate through a special messenger so as to reach this office by 16.11.2016 without fail. It is the responsibility of the Nodal officer to ensure that, the details of candidates filled in Annexure III are correct. Separate Annexures are to be submitted for I.P. & General line applicants.
