

Minutes of the 'Circle Relaxation Committee Meeting (CRC)' held on 10.07.2018 to consider the cases of Compassionate Appointment in PA/SA, PM/Mail-guard and MTS Cadre against the vacancies of 2017-2018.

The Circle Relaxation Committee (CRC) meeting was held on 10.07.2018 to consider the cases of Compassionate Appointment in PA/SA, PM/Mail-guard and MTS cadre against the earmarked vacancies of 2017-18. The CRC consists of the following members:

- 2. The members of the CRC were informed of the following points for consideration of the cases of Compassionate appointment in PA/SA, PM/Mail-guard and MTS cadre for the year 2017-18.
- i) Vacancies for compassionate appointment in PA/SA cadre earmarked under 5% vacancies of

Direct Recruitment Quota in 2017-18

- = 16 (Vacancy Statement is annexed as **Annexure A**)
- ii) Vacancies for compassionate appointment in PM/MG cadre earmarked under 5% vacancies of

Direct Recruitment Quota in 2017-18

- = 13 (Vacancy Statement is annexed as **Annexure B**)
- iii) Vacancies for compassionate appointment in MTS cadre earmarked under 5% vacancies of

Direct Recruitment Quota in 2017-18

- = 11 (Vacancy Statement is annexed as **Annexure C**)
- iv) As per Directorate's guidelines contained in Communication No. 37-36/2004-SPB-I/C dated 20-01-2010, the comparative merit point of each case has been calculated based on the following attributes of the deceased official.
 - 1) Family Pension (excluding DA & Allowances)
 - Terminal Benefits

- 3) Monthly Income.
- 4) Movable /Immovable Property
- 5) Number of dependents.
- 6) Number of unmarried Daughters.
- 7) Number of minor children.
- 8) Left over service and
- 9) Additional weight age, as prescribed, when wife is applicant.
- v) The O.M. No. 14014/19/2002-Estt (D) dated 05.05.2003 wherein the time limit of 3 years was prescribed for considering cases of compassionate appointment, has been withdrawn under DOP&T OM No. 14014/3/2011 –Estt.(D) dated 26-07-2012 keeping in view the Hon'ble High Court Allahabad judgment dated 07-05-2010 in Civil misc. Writ Petition No. 13102 of 2010. Accordingly the old cases are being placed before the CRC meeting for re-consideration.
- vi) DOP&T further issued OM No.14014/02/2012 Estt (D) dated 16-01-2013 under title head "Consolidated Instructions on Compassionate Appointment" in Rule 8 of which it is stated that, "subject to availability of a vacancy and instructions on the subject issued by the Department and amended from time to time, any application for compassionate appointment is to be considered without any time limit and decision taken on merit in each case".
- vii) In terms of DOP&T's OM No. 14014/02/2012-Estt.(D) dated 30-05-13, a married daughter can be considered for compassionate appointment if she was dependent on the Government Servant at the time of death of the official, but a married son / brother cannot be considered for the same as married son / brother is not considered dependent on a Government servant.

In terms of DOP&T OM No. 14014/02/2012-Estt (D) dated 25-2-2015 issued in modification of FAQ-No. 13 dated 30-5-2013, married sons can be considered for compassionate appointment if they otherwise fulfill all the other requirements of the scheme.

viii) As per scheme for compassionate appointment dated 16-01-2013 prescribed by Ministry of Personnel, Public Grievances and Pension applicant for compassionate appointment should be eligible and suitable for the post in all

respects under the provisions of relevant Recruitment Rules (RR). As per RR for PA/SA, the minimum educational qualification is (10+2) standard or 12th class pass from a recognized university/board for direct recruitment from open market and age limit 18 to 27 years relaxable to candidates belonging to SC/ST upto 05 years and for OBC upto 03 years. As per RR for PM/PM, the minimum educational qualification is matriculation pass from a recognized university/board for direct recruitment from open market and age limit 18 to 27 years relaxable to candidates belonging to SC/ST upto 05 years and for OBC upto 03 years. As per RR for MTS, the minimum educational qualification is matriculation or ITI pass from a recognized board for recruitment from open market and age limit 18 to 30 years relaxable for different categories as notified by the govt. of India from time to time. Public Grievances and Pensions Consolidated instructions on compassionate appointment issued under Department of Personnel & Training F.No. 14014/02/2012-Estt.(D) dated 16-01-2013 provide the following relaxations:-

- a) Upper age limit can be relaxed wherever found to be necessary. The lower age limit should however, in no case be relaxed below 18 years of age.
- b) In exceptional circumstances Govt. may consider recruiting persons not immediately meeting the minimum educational standard. Govt. may engage them as trainees who will be given the regular pay bands and grade pay only on acquiring the minimum qualification prescribed under the recruitment rules. The emoluments of the trainees, during the period of their training and before they are absorbed in the Govt. as employees will be governed by the minimum of the -1S pay band of 4440-7440 without any grade pay in addition they will be granted all permissible allowance , like DA, HRA, TA at the admissible rate. The period spent in the 1S pay band by the future recruits will not be counted as service for any purpose as their regular service will start only after they are placed in the PB-1 with GP of Rs 1800/-.
- c) In case of appointment of a widow not fulfilling the requirement of educational qualification, against the post of MTS, she will be placed in group C pay band 1 plus GP Rs 1800/- directly without insisting on fulfilling of educational qualification provided the appointing authority is satisfied that the duties of the post against which she is being appointed can be performed with the help of some job training.

3.(i) The Members of the CRC have considered all the compassionate appointment cases and recommended 16 cases for PA/SA cadre, 13 cases for PM/MG cadre including 03 candidate of CAT case and 11 cases for MTS cadre including 01 candidate of CAT case for compassionate appointment as mentioned below against the vacancies earmarked for compassionate appointment pertaining to the year 2017-18 in PA/SA, PM/MG and MTS cadre, strictly in order of merit and in order of date of death / invalidation of the deceased employee / Ex. Employee as well as taking into account the eligibility criteria prescribed for educational qualification. In other words, where merit point is same for two or more candidates against a single vacancy, preference has been given to such candidates where death of deceased official (or date of invalidation of the ex. official) had taken place earlier provided that the candidate has fulfilled the minimum mandatory educational qualification prescribed for the cadre and recommended for sending the cases to the Directorate for approval wherever the cases are more than 5 years old.

(ii) All the 52 court cases mentioned at Para 2(x) have been considered by the CRC, but the cases from sl. No. 2, 6 to 52 (except sl. No. 1, 3, 4 & 5) could not be recommended since they have earned merit points calculated as per departmental norms lesser than the last recommended candidate of the respective category i.e.; PA/SA, Postman/Mailguard, MTS

strictly in order of merit/ date of death/invalidation of the deceased/ ex-employee into account of eligibility criteria prescribed for educational qualification.


