As Circles are aware, the clientele base of PLI was extended to cover Professionals & employees of listed companies of NSE/BSE by way of a Gazette Notification amending Rule 6 of POLI Rules, 2011.

Upon receipt of gueries from Circles in respect of extended clientele base of PLI, clarifications were issued by this Directorate vide letter of even no. dated 21.11.2017.

- It is re-iterated that the above clarifications dated 21.11.2017 were in respect of cash policies of extended clientele base of PLI only. Therefore, it is again clarified that 'Certificate of Immediate Superior' will be dispensed with only in respect of cash policies of extended Clientele base. For other types of cash policies belonging to Government servant, Semi-Government servant etc., the 'Certificate of Immediate Superior' has not been dispensed with, and all such PLI proposals will, therefore, be dealt with in the same manner as they were being dealt with before.
