OFFICE MEMORANDUM

Sub: Grant of Dearness Relief to Central Government pensioners/family pensioners - Revised rate effective from 01.01.2022.

The undersigned is directed to refer to this Department's OM No. 42/7/2021-P&PW(D) dated 27.10.2021 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 31% to 34% w.e.f 01.01.2022.

- 2. These rates of DR will be applicable to the following categories:-
 - Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D)Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.
- ii. The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates.
- iii. All India Service Pensioners
- iv. Railway Pensioners/family pensioners
- v. Pensioners who are in receipt of provisio 1al pension
- vi. The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government Pensioners from Burna/ Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(B) dated 11.09.2017.
- 3. The payment of Dearness R lief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in this Depart nent's OM No. 45/13/97-P&PW (G) dated 2.7.1999 as amended from time to time. The previsions relating to regulation of DR where a pensioner is in receipt of more than one pension will em in unchanged.
