- (i) Multi Tasking Staff (MTS) in the Pay Band I of Rs. 5200- 20200 + Grade Pay of Rs. 1800/-(erstwhile) of the concerned Unit/Divisional with five years of regular service in the Grade including any regular service put in the erstwhile Group 'D' post on regular basis.

(ii) Despatch Rider in the Pay Band I of Rs. 5200-20200 + Grade Pay of Rs. 1900/- (erstwhile) of the concerned Unit/Divisional with five years of regular service in the Grade including any regular service put in the erstwhile Group 'D' post on regular basis. (for Foreign Post) The eligibility Criteria will be determined as per the RRs issued vide letter no. 4-5/2015-SPB-I

dated 05.06.2015.

Note:- Crucial date for reckoning the minimum regular service is 01.01.2019.

# Evaluation of Skill Test of Data Entry

## NATURE OF MISTAKES

- A. Full Mistakes: The following errors are treated as full mistakes:--
  - -- For every omission of word/ figure.
  - -- For every substitution of a wrong word /figure.
  - -- For every addition of a word / figure not found in the passage.
- B. Half Mistakes: The following errors are treated as half mistakes:--
  - (i) Spacing Errors: Where no space is provided between two words/figures, e.g. 'Ihope' or undesired space is provided between the words or letters of a word/figure e.g. hope I have. 'I hxxave'.
  - (ii) For every spelling error committed by way of repetition, or addition or transposition or omission or substitution of a letter/letters/figure, e.g. the word 'spelling' typed as 'seeplings' etc.
  - (iii) Wrong Capitalisation: Wrong use of capital letter for small letter and vice-versa.
