Note: Only 6 ST Surplus Candidates were Qualified in respect of 11 Vacancies.

1. The names of the candidates have been arranged in order of merit from Surplus Qualified candidates and according to number of unfilled vacancies in Postman/Mail-guard Cadre available in divisions/units for the year 2018 .The seniority will be determined in accordance with the principles laid down in the Directorate's communication no 27-24/65-NCC dated 07-04-1966 in respect of candidates who have secured equal marks in the above examination.
2. The selected SC/ST/OBC candidates should be asked to produce the original Caste certificates for detailed scrutiny by the Head of the Division/Unit to see that (i) it is issued by the appropriate authority and in prescribed form (ii) that it is genuine and complete in all respects .
3. If any discrepancy is noticed in the result or if it is found that the candidate was not eligible to appear in the examination , the candidature of the candidate should be cancelled before appointment / posting . So , the Division/Unit heads should make scrutiny of the result of the candidate before appointment . Further , if any mistake is noticed regarding the names of the candidates against their Roll Number or vice-versa the same may be corrected under intimation to the ADPS (Rectt) , CO , Kolkata-700012 .
4. As per the clarificatory order of Directorate mentioned above, the candidates enlisted in **ANNEXURE -II** is to exercise their choice of preferences for the recruiting units mentioned in **ANNEXURE – IV(list B)** for consideration towards allocation to such unit . All the candidates of **ANNEXURE – II** should submit their choice of preference (**Annexure V: Option Form**) through the respective division/unit head for onward transmission to Circle Office by **04-10-2019** positively for further process at CO level. **The order of preference once exercised shall not be changed and is final .**
5. As per the clarificatory order of Directorate mentioned above , a reserve category candidate selected against an unreserved vacancy on own merit shall have choice to migrate to reserve category if by doing so he/she can be allocated to a unit , which is higher in the order of preference exercised by him/her .

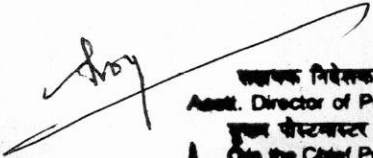

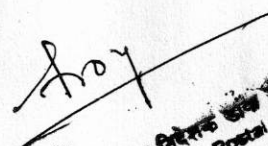
