CORRIGENDUM

This is regarding allotment of surplus qualified GDS candidates for recruitment to the cadre of Postal assistants/ Sorting Assistants for the vacancy years 2015-16, 2016-17, 2017-18, 2018 & 2019 published vide C.O. Memo No. Rectt/X-13/DR/GDS/2015-16/AD(R) dated 18.03.2020. As per PA/SA Recruitment Rules -2015, after publishing the result of LGO (Postman/ Mail Guard & MTS) candidates vide C.O. Memo dated 13.02.2020, the rest unfilled vacancies were first filled up from the eligible GDS candidates of parent units and thereafter from other Divisions/Units according to merit.

- 2. In the list of eligible surplus qualified GDS candidates allotted to other Divisions/Units for recruitment in the post of Postal assistants/ Sorting Assistants published vide C.O. Memo dated 18.03.2020, Shri Sandip Das (OBC), GDS, Bankura Division having Roll No. 01650034 with date of joining 19.06.2013 has been allotted to A&N Islands against the last available vacancy under 'UR' category for the vacancy year 2018. But subsequently, it was found that he was not at all eligible to qualify for the vacancy year 2018 due to the fact that the candidate had less than 5 years continuous service as on crucial date of eligibility for the vacancy year 2018 i.e. 01.04.2018. Hence, the name of Shri Sandip Das was deleted from the list of 2018 and his name has been included against the vacancy year 2019, being otherwise eligible for 2019 by following the instructions issued in this regard by the Directorate from time to time. Shri Sandip Das was the last candidate selected on merit under UR category in the list of surplus qualified GDS candidates for 2019 and as such he is placed against the last clear vacancy available under UR category for the vacancy year 2019 and is allotted to the last unfilled vacancy i.e. vacancy of Sikkim Division.
- 3. Smt. Pushpanjali Maity, ABPM, Contai Division having Roll No. 01850035 with date of Joining 19.03.2013 is eligible for the vacancy year 2018, and as such she should have been placed against the available vacancy of 2018 under UR category. Since Smt. Maity was the last meritorious candidate of UR category in the merit list of 2018, she should have been placed against the last clear vacancy of 2018 under UR quota which is at A&N Islands.
- 4. In view of above, the earlier placement of Smt. Maity at Sikkim Division was found erroneous and hence cancelled. In cancellation of earlier erroneous order, Smt. Maity has been placed against surplus GDS vacancy of A&N Islands against vacancy of 2018.

All other entries remain unchanged.
