Subject: - Limited Departmental Competitive Examination (LDCE) from Postman/Mail Guard, Despatch Rider and MTS for recruitment to the cadre of Postal Assistants/Sorting Assistants in Postal Divisions/Units (including Postal Store Depot), RMS and MMS for Departmental Quota of vacancy for year 2020(01.01.2020 to 31.12.2020).

In pursuance of Directorate's Communication no. A-34012/05/2020-DE dated 04.11.2020 following notification is issued:-

The Limited Departmental Competitive Examination(LDCE) will be held on **20th of December, 2020 (Sunday)** for recruitment of Postal Assistants/Sorting Assistants from Postman/Mail Guard, Despatch Rider and MTS for Departmental Quota of vacancy for year 2020(01.01.2020 to 31.12.2020). Accordingly, applications are invited from the willing and eligible candidates in the format enclosed (**Annexure-I**). The schedule of activities of the examination is furnished hereunder:-

* Exam will commence exactly at 10:00 AM and both Paper-I & Paper –II will be conducted in continuity.

2. Vacancies: Number of vacancies available under Recruiting Division/Unit-wise is enclosed as Annexure-A.

3. Eligibility Criteria:- As per the Recruitment Rules notified in GSR 411(E) dated 21.05.2015, the following categories of official(s) are eligible to appear in the examination:

- (i) Postman/Mail Guard in the Pay band I of Rs. 5200-20200 +Grade Pay of Rs. 2000/- (pre-revised) of the concerned Unit /Divisional with three years of regular service in the Grade.
- (ii) Despatch Rider in the Pay Band I of Rs. 5200-20200 + Grade Pay of Rs. 1900/- (Pre-revised) of the concerned Unit/Divisional with five years of regular service in the Grade including any regular service put in the erstwhile Group 'D' post on regular basis.
- (iii) Multi Tasking Staff (MTS) in the Pay Band I of Rs. 5200- 20200 + Grade Pay of Rs. 1800/- (pre-revised) of the concerned Unit/Divisional with five years of regular service in the Grade including any regular service put in the erstwhile Group 'D' post on regular basis.

Note: The vacancy year has been changed from financial year as provided in the Recruitment Rules to Calendar Year in terms of DoPT OM no. 22011/4/2013-Estt(D) dated 08.05.2017 and Department of Posts DO letter no. 137-15/2014-SPB-II dated 07.07.2017 and the crucial date of reckoning the minimum regular service is 01.01.2020.


4. Pattern & Syllabus of Examination: The examination will be conducted as per the revised pattern and syllabus circulated by Directorate vide letter No. 17-08/2018-SPB-I dated 10.05.2019 under Annexure-C which shall be read with letter no. 17-08/2018-SPB-I dated 20.06.2019, 26.06.2019, 28.06.2019, 11.07.2019, 23.07.2019 and 11.12.2019 and letter no. 17-08/2018-SPB-I(Pt) dated 10.06.2019 are enclosed as **Annexure-II**.

Note:- The 'Skill test of data entry' will be conducted subsequently.

5. Centres of Examination:- The examination will be conducted at **Kolkata, Howrah, Siliguri, Portblair & Gangtok centres** only. The candidates will have to appear from the respective centres of their Circle only and under no circumstances, they be permitted to appear from other Circle Centres.


6. The application of the APS candidates should be sent to the concerned Divisions only and not to Circle Office.
