

Minutes of the 'Committee on Compassionate Engagement (CCE) Meeting' held on 12-07-2022 to consider the cases of engagement in GDS cadre on compassionate ground

Total 25 cases were placed before the CCE for consideration out of which 18 cases have been recommended and the list is placed at **Annexure A**. 2 cases have been considered but not recommended due to found over-aged i.e above 40 years and the list is placed at **Annexure B**. 4 cases found belated but recommended considering several aspects and the list is placed at **Annexure C**. 1 case has been considered but not recommended as that is belated cases i.e. claim submitted after one year from the death of the concerned GDS and the reason for delay intimated by the claimants is not convincing and the list is placed at **Annexure D**.

3. In view of the above, 18 cases as mentioned in **Annexure A** were considered by the Committee and recommended.
