<u>Subject</u>:-Daily Rates of Wages of Casual Workers/ DRMs(Daily Rated Mazdoors)/Outside Driver of Inspection Vehicle/Mail Van.

As per the rate communicated by the Joint Labour Commissioner, Govt of West Bengal, the daily rate of wages of the followings who do not come under the purview of the minimum wages Act has been fixed as follows:-

i.). <u>Casual Workers/ DRMs (Daily Rated Mazdoors)</u>:- Rs. 281/- (Rupees Two hundred & eighty one) only per day (i.e. for eight hours).

This rate of wages @ Rs. 281/- is applicable for such Casual Labourer/DRM/Mazdoor/ Piece Rated Mazdoor/ Ticca Mazoor/ Piece Rated worker as the case may be, who are not being paid as per minimum wages act and also engaged for seasonal/ occasional work in P.O./RMS/ Business Offices/ Administrative Offices etc for 8 hours duty or part thereof. However for performing duty below 08 hours, wages should be paid on pro-rata basis i.e. wages @ Rs. 35.12/- (Rupees Thirty five & paise twelve) only per hour should be paid.

ii.). Outside Driver:- Rs. 291/- (Rupees two hundred & seventy only) per day (i.e. for eight hours).

The daily rate of wages of outside driver of Inspection Vehicle/ Mail Van whose wages are not regulated by any of the Statutory provisions like the Minimum Wages Act, etc has been fixed as Rs. 291/- (Rupees two hundred ninety one) only per day (i.e. for eight hours). However for his performing duty below 08 hours, wages should be paid on pro-rata basis i.e. wages Rs. 36.37/- (Rupees Thirty six hundred & paise thirty seven) only per hour.

This is issued with the concurrence of CIFA vide U.O. No. IF Cell-687 dated 26/29.2.2016 and approval of the Chief Postmaster General, West Bengal Circle, Kolkata-700012.

The revised rate will be in force with effect from 01.01.2016
