

#### Office Memorandum

Subject: Creation of new Postal Circle named "Telangana Postal Circle" subsequent to the formation of Telangana State.

The president is pleased to approve the creation of the **Telangana Postal Circle** by converting the existing Regions in those areas carved out of their parent Circle i.e. Andhra Pradesh Postal Circle.

- 2. The Headquarters of the new Telangana Postal Circle will be at Hyderabad; and the headquarters of the existing Andhra Pradesh Postal Circle will also be at Hyderabad till the Andhra Pradesh Circle is moved to Andhra Pradesh State.
- 3. The jurisdiction of the newly created Telangana Postal Circle is shown in Annexure-I and the jurisdiction of the existing Andhra Pradesh Postal Circle after carving out of the new Circle is shown at Annexure-II.
- 4. In respect of assets, staff, records etc., the new Circle will comprise all that are presently with the respective Regions concerned. However, keeping in view their respective jurisdiction as indicated in the Annexures, action for distribution of assets/staff/record etc. of the new Circle and existing Circle will be taken by both Chief Postmasters General by mutual agreement based on the functional/administrative needs of each circle. Operational aspects in this regard are placed at Annexure-III.
- 5. This order will take effect from the date of issue.
- 6. This issues in consultation with Integrated Finance Wing vide their Diary No.81/FA/2016/CS dated 01/072016.

## OPERATIONAL ARRANGEMENTS

- Post of Chief Postmaster General (HAG) for Telangana Postal Circle has already been created vide this office Memo. No.33-(1) 1/2011-PE-II dated 31-05-2016 (Sixth Cadre Review of IPoS Gr.A).
- Post of PMG (Mails & BD) will be the part of Telangana Circle. (2)
- Post of DPS (Mails & BD) will be DPS (HQ) for Telangana Circle. (3)
- Khammam postal division, presently in Vijayawada Region, will (4) be part of Hyderabad Region.
- The officers and staff working in the present Circle Office will (5) attend to the work of both circles till the bifurcation of staff and records is taken place. This process should be completed within one month.
- Both the Circles will be functioning from Hyderabad till the (6) Andhra Pradesh Circle is moved to Andhra Pradesh State.
- Director of Accounts (Postal), Circle Stamps Depot (CSD), MMS (7) (Hyderabad), Postal Civil Division (Hyderabad), Postal Electrical sub division (Hyderabad), Asst. Architect (Hyderabad), RLO and AMPC (Proposed) will be serving the both Postal Circles till separate offices are created for both the Circles.
- The present mail arrangements will remain the same for the (8) present.
- Distribution of the staff will be, as far as possible, based on (9)willingness. One time option facility may be given to all staff concerned.
- Distribution of present accommodation of Circle office, (10)furniture etc. may be done proportionately and based on requirement.
- All these arrangements will continue till there is a need to (11)review them for these two Circles.
- (12)For further clarification on any issue, the matter may be referred to Postal Directorate.
