

Sub: Amendment in Allocation of Business Rules, 1961 - reg.

The undersigned is directed to refer to notification No. Doc. CD-454/2016 dated 16th. July, 2016 to be published in Gazzette of India and to say that in exercise of the powers conferred by clause (3) of article 77 of the constitution, the President has made following amendment in Government of India (Allocation of Business) Rules 1961:

1. In the FIRST SCHEDULE-

- a) The heading "7. Ministry of Communications and Information Technology (Sanchar aur Soochana Praudyogiki Mantralaya)" shall be substituted by "7 Ministry of Communications (Sanchar Mantralaya) and Sub-headings thereto, by (i) Department of Telecommunications (Doorsanchar Vibhag); (ii) Department of Posts (Dak Vibhag)
- 2. in the SECOND SCHEDULE-
 - (i) The heading "MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SANCHAR AUR SOOCHANA PRAUDYOGIKI MANTRALAYA)" shall be substituted by **MINISTRY OF COMMUNICATIONS (SANCHAR MANTRALAYA)**
 - (ii) Under the heading "MINISTRY OF COMMUNICATIONS (SANCHAR MANTRALAYA) the sub heading "DEPARTMENT OF ELECTRONICS AND INFORMATION TECHNOLOGY (ELECTRONIKI AUR SOOCHANA PRAUDYOGIKI VIBHAG)" and entries shall be omitted.
