
ORDER

Subject: Implementation of 6th Cadre Review orders- creation of SAG/JAG Posts in Circles - change of Headquarters of PMsG in NE Circle reg.

The undersigned is directed to refer to this Directorate order of even number dated 05.07.2016 vide which one post of PMG Aizawl, North-East Circle with jurisdiction of Tripura and Mizoram Divisions and one post of PMG, Imphal, North-East Circle with jurisdiction of Manipur and Nagaland Divisions were created.
