Sub: Daily Rates of Daily rated Ticca Workers/Outside Drivers of Inspection Vehicle/Mail Van.

As per the rate circulated by the Joint Labour Commissioner, Govt. of West Bengal, the Daily Rates of Daily rated Ticca Workers/ Outside Drivers of Inspection Vehicle/Mail Van, who do not come under the purview of the Minimum Wages Act has been fixed as follows:-

i) <u>Daily Rated Ticca Workers</u>:- Rs. 387/- (Rupees Three Hundred Eighty Seven) only per day (i.e. for eight hours).

This rate of wages @ Rs. 387/-(Rupees Three Hundred Eighty Seven) is applicable for such Daily rated Workers as the case may be who are not being paid as per Minimum Wages Act and also engaged for seasonal/occasional work in Post Office/RMS/Business Offices/Administrative Office etc for 08 hours duty or part thereof. However for performing duty below 08 hours, wages should be paid on pro-rata basis i.e., wages @ Rs. 48.38 (Rupees Forty Eight & paise Thirty Eight) only per hours should be paid.

ii) <u>Outside Driver: -</u> RS. 397/- (Rupees Three Hundred Ninety Seven) only per day (i.e. for eight hours).

The daily rate of wages of outside Driver of Inspection Vehicle/Mail Van whose wages are not regulated by any of the statutory provisions like the Minimum Wages Act etc has been fixed as Rs. 397/- (Rupees Three Hundred Ninety Seven) only per day (i.e for eight hours). However for his performing duty below 08 hours, wages should be paid on pro-rata basis i.e. wages Rs. 49.63/- (Rupees Forty Nine & paise Sixty Three) only per hours.

The revised rate will be in force with effect from 01.01.2019.
