Subject: Payment of Dearness Allowance to Gramin Dak Sevaks (GDS) effective 01.01.2017 onwards -reg.

Consequent upon grant of another instalment of Dearness Allowance with effect from 1st January, 2017 to the Central Government Employees vide Government of India, Ministry of Finance, Department of Expenditure's O.M. No. 1/3/2008-E-II (B) dated 07.04.2017, duly endorsed vide this Department's letter No. 8-02/2011-PAP dated 12.04.2017, the Gramin Dak Sevaks (GDS) have also become entitled to the payment of Dearness Allowances on basic TRCA at the same rates as applicable to Central Government Employees with effect from 01.01.2017. It has, therefore, been decided that the Dearness Allowance payable to the Gramin Dak Seyaks shall be enhanced from the existing rate of 132% to 136% on the basic Time Related Continuity Allowance, with effect from the 1st January, 2017.

- The Dearness Allowance payable under this order shall be paid in cash to all Gramin Dak 2. Sevaks.
- The expenditure on this account shall be debited to the Head "Salaries" under the relevant head of account and should be met from the sanctioned grant.
