The comprehensive status report should reach undersigned latest by **31.03.2020**.



In the provisional appointment letter, it should be clearly mentioned that in case character & antecedents of the candidate is found not verified or any false information is given by the candidate in his/her self declaration, the provisional appointment letter will be cancelled forthwith and other legal action will also be taken as a consequence. (A proforma of declaration is enclosed).
