- 4. The examination will be held in accordance with the revised syllabus circulated under this office letter no. Rectt/R-24/PO & RMS Acctt./Rlg dated 30.01.1990.
- 5. The officials securing at least 60% marks in a particular Paper will be exempted from appearing in that Paper in the next two subsequent examinations, if otherwise eligible.
  - 6. The number of chances admissible is three (3) only.

- 9.If any of the candidate is not recommended or provisionally recommended, their cases should be taken up with the respective Regional PMsG for early decision under intimation to CO along with reasons for provisionally recommendation or if the case is not recommended.
