With reference to the notification for CE issued vide No. Rectt./X-16/CE/PM-MG & MTS/2025 dated 16.07.2025 and notification for DEST issued vide No. Rectt./X-16/PM-MG & MTS/2025/AD(R)/Part-1(i) dated 26.09.2025 and final vacancy position of Postman and Mail Guard for the year 2025 issued on 16.09.2025, the competent authority is pleased to declare the result of the Competitive Examination (CE) for recruitment to the post of Postman/ Mail Guard from eligible GDS candidates for the vacancy year 2025 (01.01.2025 to 31.12.2025) held on 31.08.2025 and DEST held on 07.10.2025.

2. The selection of GDS candidates through CE to Postman and Mail Guard have been done by preparing single merit list for CE at Circle level. The selected candidates have been allotted to the Divisions/Units as per their merit position (according to the total marks obtained in Paper-I and Paper-II in combination for the candidates, who have qualified in Paper-III and Paper-IV separately) and on the basis of their Option for Post/Order of preference viz-a-viz the availability of vacancies in the Divisions.

3. The list of GDS candidates selected for recruitment to the posts of Postman and Mailguard against the vacancy year 2025 with the allocation of Division and post are enclosed as per **Annexure -A**. Result in respect of 5 GDS candidates have been kept withheld in accordance with the guidelines of the Postal Directorate.

4. The information relating to particulars of the candidates, viz., name of the candidates, their roll numbers, category, Date of Birth, Date of appointment/engagement etc. have been shown on the basis of information furnished by the Regions/Divisions/Units and confirmations furnished subsequently. If it is found subsequently that any of the selected GDS candidate was not eligible to take the examination under the existing rules/instructions on the subject or for any other reasons or in case any discrepancy is found with regard to announcement of results of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject or on orders of Hon'ble CAT/High Court, if any.

5. Before issuing appointment letter to the candidates, **category of the candidates concerned claiming SC/ST/OBC/EWS/PwBD relaxation, must be thoroughly verified in accordance with the existing rules and instructions on the subject or orders of Hon'ble CAT/High Court/Supreme Court passed, if any.**

6. **The selection and appointment of the candidates belonging to SC/ST/OBC/EWS/PwBD is subject to verification of their caste status by the Division/Unit concerned in accordance with the existing rules and instructions on the subject or on orders of Hon'ble CAT/High Court/Supreme Court, if any, passed from time to time.**

7. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Regions/Divisions are requested to verify the current status of the candidature of the qualified candidates before appointing the candidates. The candidate against whom vigilance or disciplinary case is pending/those undergoing specified punishment should not be appointed and such cases should be referred back to the Circle Office as per extant of guidelines issued by the Postal Directorate from time to time.

8. The selection of the candidates is purely provisional subject to fulfilment of required conditions of relevant Recruitment Rules and verification of genuineness of various mandatory certificates of the candidates by the concerned Head of the Divisions/Units.

9. The appointing authorities are required to carry out all pre-appointment formalities as per relevant rules and instructions issued from time to time.

10. Selected candidates are requested to submit written acceptance / refusal for joining in Postman/ Mail guard cadre to their parent Division/Unit **within three (03) days positively** from the date of publication of this result. The Head of the parent Division/Unit must ensure obtaining written acceptance/refusal from the selected candidates adhering the time limit mentioned above.

11. **The Divisional/Unit Heads are requested to issue appointment orders to the successful candidates on or before 21.10.2025 positively clearly indicating that if the candidate does not join the recruited post within seven (07) days it will be deemed to have been refused as per Postal Directorate letter No. 17-08/2018-SPN-I dated 18.10.2023. Official on leave may be allowed to join even after seven (07) days if they communicate in writing to accept the appointment and in that case the official will be allowed after expiry of approved leave period. Controlling officers are advised to contact such successful candidates who are on leave for obtaining their consent to join recruited post in writing. Similarly, candidates who do not wish to join recruited post may be encouraged to communicate the same in writing.**

12. Parent Division/Unit head will send the original written refusal letters of candidates duly attested by them to concerned Regional Office (Circle Office for the HQ Region) on or before **27.10.2025**. Region Offices will send the entire original written refusal letters received from Divisions in one lot to this office on or before **28.10.2025**.

13. The contents of this memo may be brought to the notice of all concerned.
